## Transfer Articulation Agreement Between

# School of Management, Binghamton University, State University of New York and

# Bronx Community College, City University of New York

#### Introduction

This agreement is entered into by and between the School of Management, Binghamton University, State University of New York, (hereinafter identified as Binghamton University), and Bronx Community College, the City University of New York (hereinafter identified as Bronx Community College).

In an effort to better serve transfer students intending to pursue programs of study with School of Management, Binghamton University and Bronx Community College hereby enter into this articulation agreement allowing students to enroll in the School of Management through Binghamton University's 2+U guaranteed transfer admissions program with the opportunity to continue at Binghamton University in the School of Management for a Master's in Business Administration (MBA) or a Masters of Science (MS) in Accounting.

Binghamton University recognizes transfer students from Bronx Community College who wish to pursue a baccalaureate degree and will complete an AS in Business Administration, Management Option.

# Binghamton University's 2+U program is designed to:

- Facilitate the transition of graduates from the associate degree program at Bronx Community College to a baccalaureate degree program in the School of Management at Binghamton University.
- Attract qualified students to both Bronx Community College and Binghamton University.
- Provide information to ensure appropriate advisement for students from faculty and staff at Bronx Community College and Binghamton University.
- Encourage academic coordination between the faculty and advisors at the two institutions, including curricular reviews.
- Assess and exchange information on the specific outcomes of this articulation program with the goal of continual improvement.

# Qualifying Students

This agreement pertains to the transfer of "qualifying students", i.e. those students who:

- 1. Will successfully complete their associate degree in May (prior to the fall entry at Binghamton). Students who complete their associate degree in December will be considered on their individual merit and spaces available;
- 2. Have matriculated, enrolled, and are in good standing at Bronx Community College;

- 3. Have a minimum cumulative 3.3 GPA for guaranteed admissions. Candidates between a 3.00 and a 3.29 GPA will be considered based on space availability and their individual merits by the Binghamton Admissions Committee or offered an alternative major;
- 4. Complete prerequisite courses in Macroeconomics, Microeconomics, Statistics, and Calculus, earning minimum grades of "B" in three of the four courses. Note: BCC students may complete BUS 41 Business Statistics at BCC for the Statistics requirement. Additionally, they may complete calculus upon transfer to Binghamton, if not completed at BCC.

Students on track to meet the program requirements above will have access to special events organized and facilitated by the Binghamton University School of Management Transformational Leaders Program while enrolled at Bronx Community College. These opportunities are geared towards facilitating successful academic performance, but do not guarantee admission into Binghamton University or the School of Management's Transformational Leadership Program. Bronx Community College will share names and contact information of interested enrolled prospective students with Binghamton University. They will jointly host an interest meeting in November to connect with prospective students.

Prospective School of Management students should complete an admissions application for Binghamton University by January 15 and submit a three semester transcript inclusive of the most recent fall grades by February 1. Any applicant who applies or submits materials after the deadline will be considered on a space available basis. To continue in the MBA or MS Accounting program, eligible students must have a minimum undergraduate Binghamton GPA of 3.4 (with no grades less than a B- in core business and accounting courses) and submit an application for the Graduate program during their senior year by the recommended deadlines- March 15 (fall) or December 1 (spring). For application procedures, please consult with the Graduate Advisor.

Given the competitive nature of admissions at Binghamton, guaranteed space is limited to 25 Bronx Community College participants annually for matriculation in the fall semester.

All students who participate in the Binghamton University 2+U program are expected to complete all coursework at Bronx Community College until meeting the academic requirements to successfully transfer into Binghamton University. Requirements for the bachelor's degree those in effect at the time the students transfers based on catalog year in which they enter the School of Management at Binghamton University. Approved coursework is listed online

Binghamton University's School of Management requirements, general education requirements and detailed information are contained in the attached document. The most up to date information for Binghamton University is listed in its bulletin.

Credits awarded through programs including Advanced Placement (AP), International Baccalaureate (IB), and the College Level Examination Program (CLEP) will also be considered for transfer based

upon official proof of minimum required scores. More details about these type of equivalencies are available online at:

Each institution hereby agrees to notify the other in the event of a substantive changes in a course, program, or policy at its institution that would impact the agreement, including the courses and provisions herein.

In August of 2022, the School of Management, Binghamton University and Bronx Community College agree to enter into an articulation agreement as described above, via one through four of the Articles of Articulation and the Transfer Information/Curriculum Planning Guide.

Evaluation of this agreement will occur every five (5) years. At the request of either party, a review of the contents, updates and/or implementation of the agreement will be conducted by the institutions. Binghamton University and/or Bronx Community College will give not less than one calendar year's written notice for a termination of the articulation agreement.

The undersigned agree to all the stipulations outlined above and in the attached document.

#### ARTICLES OF ARTICULATION

- This document and the attached curriculum planning guides describe the requirements for the Bachelor
  of Science degrees in the School of Management. The planning guides also provide information about
  approved Binghamton University transfer course equivalencies that should be taken in the first two
  years of study at Bronx Community College to fulfill University General Education and/or School of
  Management requirements.
- 2. Credits awarded through programs including Advanced Placement (AP), International Baccalaureate (IB), and the College Level Examination Program (CLEP) will also be considered for transfer based upon official proof of minimum required scores. - 3. Each Institution hereby agrees to notify the other in event of substantive changes in a course, program, or policy at its institution that would have an impact on this agreement, including the courses and provisions herein. Bronx Community College shall notify the School of Management anytime course syllabi and/or contents are significantly altered, or if new courses should be reviewed for equivalency. Substantive changes to the degree program at Binghamton University will be reflected in the Bulletin and in the guide materials on the website, and due notification shall be made to Bronx Community College. All such notifications shall be made as early as reasonable.
- 4. Evaluation and renegotiation of this agreement will occur every five (5) years. At the request of either party, a review of the contents and/or implementation of the agreement will be conducted by the institutions. Binghamton University and/or Bronx Community College will give not less than one calendar year's written notice for a termination of the articulation agreement.
